## Productivity Commission releases Report on Government Services

on Tuesday 24<sup>th</sup> January 2017*

On 24<sup>th</sup> January 2017, the Productivity Commission released its Annual Report on Government Services (RoGS). The annual report on government services provides information on the equity, effectiveness and efficiency of government services in Australia.

Volume G of this report relates to Housing & Homelessness and includes the following data relating to the community housing industry.

In South Australia, the significant increase in new households assisted and tenancy units from 2015 to 2016 reflects transfer to the community sector of a large number of public housing dwellings.

Implementation of the National Regulatory System in SA resulted in most Community Housing Providers merging with other larger groups resulting in a decline in the total number of providers between June 2014 and June 2016.

The proportion of South Australian community housing tenants that rated amenity aspects as important and meeting their needs exceeded national averages in a number of areas as follows:

- Size of dwelling – 91.1% (national average 87.7%)
- Car parking – 91.3% (national average 83.5%)
- Yard space & fencing – 87.1% (national average 84.4%)
- Privacy of home – 90.4% (national average of 87.0%)
- Safety of neighbourhood – 84.7% (national average of 82.8%)

The overall satisfaction level for South Australian community housing tenants was 88.1% ahead of the national average of 85.8%.

## Malcolm Turnbull appoints new assistant minister to tackle housing affordability

Prime Minister, Malcolm Turnbull, as part of a reshuffle of his ministry, appointed Michael Sukkar MP, as the new Assistant Minister to the Treasurer. Mr Sukkar’s key focus will be on housing affordability.

UDIA President, Michael Corcoran, said he was very pleased to see that the Government was prioritising the need to address the housing affordability crisis in our major cities as a key priorities and he congratulates the new Assistant Minister on his appointment.

The Assistant Minister has bucked the suggestion that removing negative gearing was a viable solution. “What we need to be doing, and the position Mr Sukkar thinks the government will take, is to increase supply.” UDIA has made housing affordability a key plank of its advocacy agenda in 2017 and will be focussed on formulating policy and research initiatives to provide solutions to the government.

## Public housing transfers move to a new level

With the NSW Government’s recently announced tranche of public housing transfers to not-for-profit providers, Australia’s community housing sector is set for a new growth spurt. The addition of the 14,700 former Housing NSW properties – the largest program yet – will expand existing national community housing provider (CHP) holdings by almost a quarter to over 90,000.

While small-scale public housing transfers are nothing new, AHURI’s report (published in the 01/17 edition of the CHCSA E-Bulletin) on recent programs highlights a number of significant departures from previous practice. In particular, contrasting with earlier handovers which often involved 3-year leases, these generally incorporate long-term (typically 20-year) management contracts between the relevant state government and the chosen CHP. With the recent introduction of PR Connect which allows people to apply for a bond online, Housing SA has introduced new eligibility criteria for the receipt of bonds. This includes:

- Not having a debt of more than \$1,000 with Housing SA
- Have an arrangement in place to repay any Housing SA debt
