Growing housing supply crisis in SA for low-income earners

Low-income earners are trapped in a housing supply crisis, with only 4 per cent of 4000 vacant rental properties deemed “affordable”, a new survey shows.

A snapshot of the housing rental market in Adelaide this month revealed the growing gap in the availability of budget accommodation.

The housing crisis has prompted calls by welfare groups for the State Government to establish a \$250 million loan scheme to build more affordable housing and reduce homelessness while creating jobs.

“The idea of the loan scheme is to give extra help to community housing providers at a slightly cheaper rate to build homes. This will enable registered CHPs to build and deliver more affordable housing to people who need it most.” To read the full article click [here](#)

Federal Treasurer's address on housing affordability

The Treasurer, the Hon Scott Morrison, addressed the issue of housing affordability in an hour-long lecture hosted by AHURI at the State Library in Melbourne on Monday 10th April 2017.

Treasurer Morrison said “Today I want to turn our attention to the rental housing sector, and the increasing pressures being placed on our social and affordable housing programs.

Around 47 per cent of low-income rental households in our capital cities spend more than 30 per cent of their household income on housing costs. In short we need more housing, not just for homeowners, but for renters.

Montrose House, a new respite home for young people aged 5-20 years and living with disability, will provide more options for families and carers in Adelaide’s southern suburbs.

Energy efficiency assistance for SA households

The Retailer Energy Efficiency Scheme (REES) is an SA government initiative that requires energy retailers to help households and businesses save on energy use and costs, and lower their greenhouse gas emissions. To do this, energy retailers need to meet energy efficiency and audit targets that have been set for them.

South Australian households and businesses may be able to receive free or discounted energy efficiency activities from energy retailers participating in the REES. Common activities include installing water efficient shower heads, to help save water heating costs and installing energy efficient lighting.
