Budget's housing affordability measures welcomed

As published in a CHIA Media Release on 9th May 2017

The Federal Government's package of housing measures, announced by Treasurer Morrison in the 2017 Federal Budget, provides a solid base for long-term reform that will lead to improved housing affordability over the next decade, according to Community Housing Industry Association (CHIA). CHIA CEO Peta Winzar described the package as 'a balanced set of measures'.

'Setting up a financial intermediary to raise funds from institutional investors was one of the key measures on CHIA's wish list for this Budget. 'The \$1 billion the Government has set aside for the National Housing Infrastructure facility to boost housing supply is an excellent start,' Ms Winzar says.

CHIA also welcomed the new National Housing and Homelessness Agreement, which will tie Commonwealth funding more closely to improvements in homelessness and housing affordability. The government's fact sheet on the new agreement can be found [here](#)

Anglicare SA’s Rental Affordability Snapshot

If you’re a single person on income support and looking for a private rental across Adelaide’s metropolitan area, there’s almost no chance you’ll be able to find a house according to the findings of Anglicare’s latest *Rental Affordability Snapshot (RAS)*.

The results of the survey highlighted that of the 3,661 private rentals advertised on the day the snapshot was taken, only 62 or 1.7% were affordable and appropriate for a single person on income support. Only 1,536 or 42% were affordable and appropriate for households on the minimum wage.

Funding housing: NDIS payments back new accommodation for disabled youth

National Insurance Scheme Disability funding has been used for the first time to develop housing that has moved young people with disabilities out of aged care homes.

Non-profit foundation Summer Housing purchased 10 apartments in a 110-unit building completed by developer BaseBuild in Newcastle’s Belmont last year and modified them during construction for clients with disabilities. Specialist Disability Accommodation payments top up the rent that qualifying NDIS recipients pay and give accommodation owners a secure and commercial income stream.
