AIHW releases *Housing assistance* in *Australia 2017* report

The Australian Institute of Health & Welfare has published its report titled *Housing assistance in Australia 2017* which provides up-to-date information relating to government funded provision of social housing, rent assistance, home purchase assistance and support services to help households maintain their tenancies.

Secure and affordable housing is fundamental to the wellbeing of all Australians. It provides a platform for many of life's benefits, including stable employment, connection to the community and a sense of home. Unfortunately, many Australians are not able to access affordable, suitable housing with their own economic and social resources. Assistance provided by governments and community organisations is available to eligible Australians who may have difficulties securing stable and affordable housing – this support is collectively referred to as housing assistance.

Key findings in the report include:

- 845,400 tenants lived in social housing in 2016
- 194,600 households were on social housing waiting lists in 2016

Australia is building too few homes in low income brackets

When it comes to housing, a common argument put forward is that the key to addressing affordability revolves around beefing up new supply. According to that argument, Australia is simply not building sufficient levels of new housing in order to meet demand associated with a growing population. Increase levels by enough, it says, and housing and affordability pressures will ease.

Yet new research suggests the problem may be more nuanced than that. In a recent study, the Australian Housing and Urban Research Institute (AHURI) found that almost eight in 10 new houses (78.3 per cent) which were approved for construction in Australia throughout 2013-2014 were aimed within the top four of 10 deciles from a price point perspective – up from 72.5 per cent as recently as 2005-2006. At the other end of the scale, just 5.8 per cent of new houses approved were aimed at the bottom four pricing brackets.

Michael Lennon, managing director of Housing Choices Australia, said there is a shortage of housing across the board but this is more pronounced at the lower end of the pricing scale. To read the full article click here

Low income earners in SA to benefit from increase to concessions

The State Government's utility concessions will be increased annually in line with the Consumer Price Index to assist people on low and fixed incomes with cost of living expenses. This is the first time that concessions have been indexed in South Australian and it was effective from the start of the month.

Increased utility concessions will benefit South Australian pensioners, retirees and low-income earners. Concessions that have increased are Cost of Living Concession, Energy, Water, Sewerage and Medical Heating and Cooling. Reducing reoffending: 10% by 2020 – New foundation housing program

Upon becoming Minister for Correctional Services in early 2016, the Hon Peter Malinauskas MLC noted three statistics that stood out as key indicators of the substantial challenge facing our prison system.

The first was the fact that the prison population is growing at 6.01% per year. The second, is that over 75% of our current prison population have been in prison at least once before. And finally, that the rate of reoffending is 46%. Reoffending has substantial costs for our community. It means more crime, more victims and more expense to the taxpayer through costly court proceedings and incarceration.

However, a reduction in reoffending means a safer community and frees up Government resources to invest in more productive community services.
