# Adelaide earmarked to pilot bold US program to end homelessness

As published in a Media Release on the Don Dunstan Foundation website

A broad coalition of organisations has come together to lead the charge for Adelaide to become the first city outside North America to implement an approach that has seen seven communities achieve Functional Zero homelessness.

"The Don Dunstan Foundation has a proud history of engaging with homelessness issues. We think that in 2017, Adelaide shouldn't be seeking just to address street homelessness but to end it" Foundation Executive Director David Pearson said.

On any given night there are up to 120 people sleeping rough in the city. The Adelaide Zero Project is modelled on an approach being implemented across a network of 75 US communities, and involves a coordinated, ongoing effort that aims to make service systems work better to match the need for housing with supply.

The Social Housing Minister Zoe Bettison MP supports the project. "South Australia leads the nation in its response to homelessness and this project is yet another example of this," she said.

## NRSCH releases 2016-2017 sector snapshot

The National Regulatory System for Community Housing has recently released the NRSCH Sector Snapshot 2016-2017. Highlights include:

- As at 30<sup>th</sup> June 2017 there were 284 registered providers representing a growth of 14% over 12 months
- Over 67,000 community housing properties are managed by NRSCH registered providers

## NSHS shows positive results for community housing

The National Social Housing Survey, recently published by the Australian Institute of Health and Welfare provided feedback from almost 10,000 social housing tenants surveyed. As at 30 June 2016, there were 432,800 social housing dwellings across Australia which includes 80,200 (19%) community housing properties.

The survey reported that 84% of community housing tenants rated their house and facilities in good condition and 81% of houses were adequately utilised based on Canadian occupancy standards. 74.8% of community housing tenants with a need for assistance were satisfied with the services provided by their housing organisation.

Housing assistance policy has changed substantially over time with the provision of social housing moving away from focussing on low-income working families. The most vulnerable are considered to be in the greatest need and are given priority access to social housing. In community housing, just over 4 out of 5 allocations (84%) were made to those in greatest need.

## Why there's no quick fix to housing affordability

Australia's chronic demand for new homes, driven by population growth in the big cities, is unlikely to ease in coming decades, escalating the need for bold policy that recognises that not everyone will own a house in the future, a major report by the Committee for Economic Development of Australia finds.

Warning that housing affordability is not likely to improve over the next 40 years, CEDA argues that to fix the problem there needs to be better land release, stronger tenants' rights, a shift to land-based taxation over stamp duty, and increased capital gains taxations.

The proportion of people living in capital cities is projected to rise from 66% to 74% in coming decades, accentuating demand for homes. Australia's growing population needs to be housed. If people want to live in cities, we need to adapt to and accept higher population densities. We also need to accept that in future most people will live in apartments and will often be renting. ### When to use a Section 90 application to terminate a tenancy

Consumer and Business Services produce a range of Fact Sheets that provide valuable information for community housing providers in dealing with their tenants.

Section 90 of the *Residential Tenancies Act 1995* (the Act) gives the South Australian Civil and Administrative Tribunal (SACAT), the power to end a residential tenancy agreement where the tenant has used the premises for an illegal purpose, caused or permitted a nuisance or interference with peace, comfort and privacy of another person who resides in the immediate vicinity of the premises.

An application can be lodged by any interested person who is adversely affected by the conduct of the tenant. Evidence must be provided to support your case which includes details of specific incidents. SACAT will only consider eviction after other reasonable means of resolving the situation have been exhausted. ## NDIS transition for group home residents

The NDIS rollout dates for residents of group homes (supported accommodation) provided by the State Government or a non-government organisations are now available by clicking <a href="https://example.com/here-purple-state-purp

Group home residents will start to enter the NDIS depending on the location of the home. NDIS will contact group home residents, or their family or guardian by phone and will ask questions to confirm access to the NDIS.
